#### **Beaucrroft Mobile Phones Policy**

#### **Guidance on Pupil Use of Mobile Phones**

This policy is to provide guidance and information on some of the issues arounds the use and misuse of mobile phones at Beaucroft Foundation School. It will clearly set out the school's expectations and rules around their use.

#### **Introduction Purpose:**

For many adults and young people today the ownership of a mobile phone is considered a necessary and vital part of their working and social life. There are a growing number of pupils who now have personal ownership of a mobile phone, including smart phones with internet capability, an integrated camera and video recording capability. When used creatively and responsibly this type of phone has great potential to support pupils' learning experiences and Beaucroft is beginning to incorporate such devices, along with other well established mobile devices such as the I-pad or tablet computers, into their curriculum.

- ·The widespread ownership of mobile phones among young people requires that school administrators, support staff, teachers, students, parents, and carers take steps to ensure that mobile phones are used responsibly within Beaucroft School.
- · Beaucroft School recognises the potential for both mobile phones and cameras to be used inappropriately and compromise the confidentiality of the children in our care.
- · This Acceptable Use Policy and the Example of Misuse of Mobile Phones is designed to ensure that potential issues involving mobile phones can be clearly identified and addressed.
- · Beaucroft School has established the following Acceptable Use Policy for Digital Technologies that provides teachers, support staff, students, parents and carers guidelines and instructions for the appropriate use of digital technologies during school hours.
- · Parents or carers must read and understand the Acceptable Use Policy before students are given permission to bring mobile phones to school.
- · The Acceptable Use Policy for Digital technologies also applies to students during school excursions, residential visits, extra-curricular activities or when deemed necessary for curriculum activities e.g. travel training.

#### Responsibility:

Reception – Yr 11 students bringing a phone into school should hand it into their class team for safe-keeping during the day – and collection at the end of the day. Exceptions to this rule may apply to pupils in the senior school who may need to access their mobile phones for curriculum activities throughout the week. Post 16 Students are allowed access to mobile devices if parents or students if over 18 have read and understood the Acceptable Use Policy. Mobile phones in post-16 should be kept in the student's locker switched off or on silent during classes.

### **Acceptable Uses and Misuse of Mobile Phones**

## **Pupils:**

## **Example of Misuse of Mobile Phones**

- Online bullying by text, image and email messaging
- Taking and sharing inappropriate pictures
- Access to inappropriate websites bypassing the school filtering system
- General disruption to learning caused by pupils accessing phones in lessons
- Making disrespectful comments, misrepresenting events or making defamatory remarks
   about teachers or other pupils
- Pupils using digital technologies to contact parents during activities or immediately following an incident so that the ability of staff to deal with an incident is compromised.
- Pupils posting material on social network sites with no thought to the risks to their personal reputation and sometimes with the deliberate intention of causing harm to others
- The deliberate engineering of situations where people's reactions are filmed or
  photographed in order to humiliate, embarrass and intimidate by publishing to a wider
  audience such as on Facebook or YouTube
- Publishing photographs of vulnerable pupils, who may be on a child protection plan, where

Parents / Carers are reminded that in cases of emergency, the school should be the first point of contact.

#### Staff:

- · No member of staff should have a phone on their person during teaching time.
- · Mobile phones can be used at break times outside, in the staffroom or in an empty room
- · No staff member should ever give their personal phone numbers to pupils or parents.
- · No member of staff will on any occasion use the camera function on their phone either in school or on educational visits.

All visitors (including parents and contractors) should switch off their phones when they are on school / college premises.
